#### **Hubert Algie, BFA (Monash), LLB (VU)**

Has worked in the Planning and Environment Law field for over 7 years at the Specialist Town Planning and Environment Law Firm, Kellehers Australia. He holds a Bachelor of Fine Arts from Monash University, and a Bachelor of Law from Victoria University. Recently he was awarded the 'Young Professional of the Year' award by the Victorian Planning, Environment and Law Association (VPELA). Hubert is the past President of the Victoria University Law Society known as 'Dictum Society'. During his Studies he created and led an innovative advocacy program, actively aiming to involve 'outlier' or nervous students, responding to a perceived unmet need between formal academic advocacy course work and practical student advocacy such as moots. Paul graduated with a Juris Doctor degree from the University of Wyoming in 2013. He has been admitted to practiced law in Colorado since 2014. #### **Prof. Dr. Jörg Fedtke**

is co-director of the Berlin Program. Jörg Fedtke was educated in Zambia, the Philippines, and Germany, he holds the A.N. Yiannopoulos Professorship in Comparative Law at Tulane Law School. He is an expert in public law, tort law, and comparative methodology. Based at the University of South Africa (UNISA) in Pretoria he completed an extensive analysis of the legal transplants in South Africa's Constitutions of 1993 and 1996. Within the framework of the 'Democratisation Assistance Programme' of the German Foreign Office, Professor Fedtke has provided expert advice on questions of constitutionalism to members of the Iraqi National Assembly and, in the context of the United Nations Development Programme (UNDP), for the Office of Constitutional Support (OCS) of the United Nations Mission for Iraq (UNAMI).



### **Lela Porter Love, J.D. (Georgetown)**

Professor of Law and director of the Kukin Program for Conflict Resolution at Benjamin N. Cardozo School of Law (NYC) and the Cardozo's Mediation Clinic. Specializes in community, employment, family, human rights, school-based and commercial cases. Serves on the Council of the ABA Dispute Resolution Section and the NYS Unified Court System Alternative Dispute Resolution Advisory Committee. Served as a trainer and consultant to established trainee programs for mediation in several states of the USA.



### **Moti Mordehai Mironi**

**Ph.D. (Cornell), M.A. (University of Minnesota), LL.B (Hebrew University)**

Professor of Law at Haifa University, Faculty of Law, Visiting Professor at Humboldt University Faculty of Law and Visiting researcher at the Alexander von Humboldt Institute for Internet and Society. Formerly he was a Visiting Professor at Cornell University and USC Law School. Prof. Mironi's areas of teaching and research include mediation, negotiation, A.D.R., arbitration, labor and employment law. He has published many books and articles in these fields. His recent article entitled «Mediation v. Case Settlement: The Unsettling Relations between Mediation and Courts – A Case Study» will be published shortly in the Harvard Negotiation Law Review. Prof. Mironi has successfully mediated and arbitrated major disputes including international and domestic commercial disputes, nationwide labor and employment disputes, as well as large public policy and community disputes. He serves on the mediation panel of WIPO (World Intellectual Property Organization), CAS (Court of Arbitration for Sport) and Milan Chamber of Commerce.



### **Timothy Ray, JD (Loyola, New Orleans)**

is an attorney, licensed to practice law before the United States District Court, Eastern District of Louisiana, and all State of Louisiana Courts. He serves on the faculty of the University of New Orleans, Political Science Department. He is a volunteer Notary Public for the Broadmoor Improvement Association and a volunteer mentor with the Silverback Society.

Tim has served on the Summer School Law Faculty of the Institut für Anwaltsrecht at Humboldt University in Berlin since 2013, where he teaches courses in Negotiation and Mediation.

A native of New Orleans, Tim earned a Bachelor of Arts degree in Music Performance from Dillard University and a Juris Doctorate degree with an advanced certification in International Law from Loyola University, College of Law. He completed training to become a certified mediator and negotiator at the Institut für Anwaltsrecht in Berlin, Germany.
